1. With reference to your bid submitted against the above referred tender, the competent authority has been pleased to award contract to your firm to provide 2 nos. of Food Kiosk Services at AIIMS, Kalyani, NH 34 Connector, Basantapur, Saguna, P.O. Ghoragacha, Kalyani, District: Nadia West Bengal 741245 as per the following rate agreed by your firm along with terms and conditions of the tender:
2. You are hereby requested to be present at AIIMS Kalyani to execute the necessary contract agreement as per the prescribed format on the rupees 100 (rupees One hundred only) non-judicial stamp paper within 30 days from the date of notification of Award. The contract will be regulated as per the terms and conditions of the tender and agreement to be executed.
3. Financial rent provide as per e-tender requirement (as per Gov. rules under CPWD vide letter no: 23(1)/Misc. / EE (L-Fee) / Kol /2021-22/1846 dated 23.09.2021) Considering all the facts, that EOI for Small shops like, Vegetable / grocery, stationary, barbershop, food Kiosk etc. i.e. not less than Rs.295/- per sq.m. per month and the bidder who offer above may be termed as H1 and EOI may be allotted to H1 bidder accordingly.
4. This award of contract shall be valid after completion of all the formalities and as per the clauses, terms & conditions of the E-Tender document.
5. This award of contract shall be valid for a period of **ONE** year from the date of agreement. Extendable upto **ONE** year after satisfactory performance and with the permission of competent authority.

6. You have to complete the supply, installation and commissioning of all brand new Food Kiosk (equipment with accessories and ready for providing service as per e-tender specifications within **90 days** from date of award of contract .
7. Penalty shall be levied @0.5% of the contract value for the delay in installation of Dietary equipment for each week of delay or part thereof, until entire installation is completed, subject to a maximum of 10% of the contract price for delay in installation, commissioning and service.
8. The rates and prices quoted by your firm shall be fixed for all the items complete in all respect during the duration of the contract.
9. The contractor should have valid labour license, trade license and other licenses as required under the law; if the bidder does not possess any such license for Kalyani jurisdiction, the bidder has to obtain same within one month of receiving award of contract.
10. In this respect we also request you to submit the performance security of rupees **200000.00 (rupees Two lakh only)** within 30 days from the date of award of contract in favour of "the executive director, AIIMS Kalyani" by way of "PBG/FDR/DD" from nationalized/commercial bank valid for 1 years and 60 days. The quantum of performance security is subject to revision at any time after increase of billed amount. After 1 year performance security will be applicable as per the rule, if the contract will be extended.
11. The equipment/good required starting the services at AIIMS, Kalyani shall be at the cost and risk of the service provider for which necessary arrangement may be made by them.
12. The licensee shall obtain and arrange 3rd party insurance policies to cover all the incidents from/to workmen and all equipment involved in the outsourcing of services, against any mishap. The insurance policy for the workers to be involved for Food Kiosk services shall be obtained every year by the service provider till the last date of completion of contract.
13. However, in case of any defaults or negligence under the said contract, the Food Kiosk services Committee may suggest to the Authority of AIIMS Kalyani to impose fine or penalty as per penalty clause of tender against the contractor or termination of the contract, which will be binding upon you without any representation.
14. The performance security will be returned after two (02) month of expiry of contract period after giving no dues certificate from respective department of AIIMS, Kalyani.
