- i. The Vendors/Subscription Agencies can update well in advance, the documents such as Certificates, Purchase Order details etc, under My Document option and these can be selected as per tender requirements and then attached along with bid documents during bid submission. This will ensure lesser upload of bid documents.
- ii. After downloading/getting the Tender Schedules, the Vendors/Subscription Agencies should go through them carefully and then submit the documents as per the Tender Document, otherwise, the bid will be rejected.

- ix. Generally, the permitted file format in the portal are pdf / xls / rar/ jpg formats. File name should not contain special characters like & comma etc. If there is more than one document, they can be clubbed together.

#### Scope of Work and Terms & Conditions

- I. Scope of Work: 'Empanelment of Vendors/Subscription Agencies to the AIIMs, Kalyani' for 'Supply of Indian/Foreign Print Journals published by the Indian and Foreign Publishers to the AIIMs, Kalyani'
- II. Duration of Empanelment : 2 [two] years (from the date of empanelment)

#### III. Eligibility/Pre-Qualification Criteria:

- a. The Vendors/Subscription Agencies must be in 'Supply of Indian/Foreign Print Journals in India for at least 3 years i.e. 01.04.2019 to 31.03.2022 [Separate sheet should be submitted along with the documentary proof].
- b. The Vendors/Subscription Agencies must have average annual turnover of at least Rs. 50 Lakhs (Fifty Lakhs) during five years i.e. 01.04.2017 to 31.03.2022 in the above mentioned job. A separate sheet should be attached duly attested by any Chartered Accountant/Competent Authority.
- c. The Vendors/Subscription Agencies should have an experience in serving an organization of reputed like that of AIIMs, Kalyani.
- d. The Vendors/Subscription Agencies must have furnished valid Trade License, Service Tax, Professional Tax, GST, IT Clearance Certificate, etc.
- e. The Vendors/Subscription Agencies must upload a valid PAN/TAN/GST number.
- f. The bid shall be rejected if one criterion, mentioned above, would be failed to submit.

#### IV. Terms and Conditions

- 1. The suppliers after receiving the subscription order/s along with the list of journals and newspapers will pay in advance to the respective publishers' on behalf of the AIIMS, Kalyani and submit bill with documentary proof along with i) Agreement Paper (Rs.50/-) ii) 15% bank Guarantee / FDR. iii) Invoice iv) Publishers Price proof v) State Bank of India conversion rate on the date of remittance within fifteen (15) days from receiving the order. While submitting the proof of remittance, only publishers' acknowledgement (mail is not acceptable) of the payment towards the relevant subscription would be accepted. The AIIMS, Kalyani will verify the payments details from the publishers, if needed. The AIIMS, Kalyani will not entertain any other form of remittance proof i.e.; cheques, bank drafts, were transfer etc. Within Forty five (45) days of the order letter date, vendor/publishers will have to submit publisher's acknowledgement/confirmation. After receiving the acknowledgement/confirmation from the publisher along with subscription number, the AIIMS, Kalyani will release the payment through RTGS (Real Time Gross Settlement) in favour of vendor.
- 2. The supplier shall prepare invoice/s at current State bank of India conversion rate on the date of remittance. The invoice must accompany price proof and the proof of bank conversion rate on the date of invoice. Payment will be released on receipt of only publisher's acknowledgement of the payment towards the relevant subscription. The AIIMS, Kalyani will not entertain any other form of remittance proof, i.e., photocopy of cheque, photocopy of bank draft, wire transfer paper etc.
- 3. The supplier shall ensure the delivery of each issue of journals as per enclosed list of the order. The Library will not accept any photocopy of any missing issue.
- 4. In the event of any dislocation of any copy of the newspapers or journals in transit or in the event of the agent failing to supply any such copy after its publication for any reason whatsoever, the supplier shall replace all such copies as may have been dislocated in transit, to the AIIMS, Kalyani without any extra charge on receipt of

intimation on this behalf.

- 5 The AIIMS, Kalyani will not accept any credit note for non-receipt of any journal/newspaper. Instead, the agent would have to ensure to give Bank Draft to be drawn in favour of the Executive Director, AIIMS, Kalyani, AIIMS, Kalyani, Government of India for the same.
- 6. That the vendor/supplier will supply the issues of the journals/newspapers to the AIIMS, Kalyani through their Messenger/Registered Post.
- 7. The AIIMS, Kalyani has the right to cancel the order if the supplier does not submit the invoice along with required documents within the stipulated time mentioned in the subscription order and as such the AIIMS, Kalyani reserves the right to issue order to other suppliers for the same titles.
- 8. The AIIMS, Kalyani reserves the right to stop issuing order to any supplier from the following year if the performance of the firm is found unsatisfactory. In such cases the supplier must refund the paid amount due from the firm for missing/non-supplied issues of journals, if any, to the AIIMS, Kalyani.
- 9. a. Claims for missing issues shall be settled within 18 months from the date of Supply Order failing FDR/ Bank Guarantee will be forfeited.
  - b. In addition to, if the settlement is not within the above mention deadline and if the number of missing issues is more than 2% of the order value, the vendor shall have to pay extra 10% of the total amount of missing journals.
- 10. In certain cases, supplementary invoice/s may be raised:
  - a. For pro-rata amount for replacing the missing issue/s after settlement and
  - b. For increase in price of journals by the publisher/s later on, in such case, the supplier shall raise supplementary bill for the amount due from the subscriber with documentary evidences remitting the excess amount of the increased price to the publisher.
- 11. Claims for missing journals shall be made within ninety (90) days of the publication of the issue. In case of delivery by the agent, the journal supply shall be reviewed every quarter between the agent and the subscriber.
- 12. Bank Guarantee / FDR will be with the Executive Director, AIIMS, Kalyani, AIIMS, Kalyani, Government of India till settlement of all issues.
- 13. In the event of any question, dispute or difference arising under or out or in connection with the construction, meaning, operation or effect thereafter of any matter contained therein or as to the rights, duties or liabilities of the parties hereto respectively however, in connection with these presents (except as to matters, the decision of which is herein before specially provided for) the same shall be referred to the sole arbitration of any person appointed by the Executive Director, AIIMS, Kalyani of the AIIMS, Kalyani and the decision of the arbitrator is final and binding upon both the parties.

#### V. Physical conditions of the title(s)

- a. The Library does not accept defective, damaged, soil copy of journals.
- b. Supply of journals, other than ordered will not be accepted.
- c. In case of any doubt regarding the supply, clarification should be taken from the AIIMs, Kalyani prior to the execution of the order, failing which, the decision of the AIIMs, Kalyani shall be binding on the supplier.

Note: If any journal supplied by the Vendors/Subscription Agencies is not approved by the competent

authority or found defective, damaged, duplicate and the said journal shall need to be collected by the Vendors/Subscription Agencies from the Central Library of AIIMs, Kalyani within 60[sixty] days.

#### VI. Price

- a. The price charged in the bill shall be the published price as per the Publishers' Price Proof submitted.
- b. Increase of price by rubber stamping or pasting tables for by superimposing or paper or changing page or otherwise, shall not be allowed. Any such action will be treated as irregular and price of the title with such irregularities will be disallowed.
- VII. a.
