#### **TERMS & CONDITIONS**

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. - 2. **Tenure**: The assignments are purely on contract basis for a period of **36 months or completion of the project whichever is earlier**.
