GENERAL CONDITIONS

1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Kalyani (West Bengal).
2. The aspiring applicants satisfying the eligibility criteria in all respects can bring their application on the day of the interview in the prescribed format attached herewith along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences, etc.
3. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria up to the date of publishing this notification on the Institute website failing which their application will be rejected.

6. Maximum Age-limit: -

Tutor: - Not exceeding 30 (Thirty) years as of the date of publishing this notification on the Institute website.

- (i) Upper age limit shall be determined as of the date of publishing this notification on the Institute website.
- (ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.
- (iii) Age relaxation permissible to various categories is as under -

Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

7. Candidates applying under any of the reserved category posts, viz. OH will be considered subject to OH Certificate issued by the appropriate/ Competent Authority on the prescribed format. The community should be clearly and legibly mentioned in the Certificate.

8. Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. A person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in the prescribed format.

9. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be canceled at any stage if it is found that their educational qualification or experience is not recognized by the Govt. of India.

10. The post of Tutor will be governed by CCS (Temporary Service) Rules.

11. **Qualifications and Experiences:** Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. **The experience will be counted up to the date of publishing this notification on the Institute website.**

12. Mode of Selection: - Based on the reporting, the Interview will be conducted after verifying the application and requisite documents of the candidates. The selection of the candidates will be based on their performance in the walk-in interview only.

13. Selection Procedure: - i) The candidate can apply for more than one post out of the enlisted Departments.

ii) The merit list (selected and waiting list) for all categories i.e., UR/OBC/SC/ST shall be prepared on the basis of personal interview.

iii) Any vacancy arises because of non-joining by selected candidates in this selection or by the resignation of candidates; the post will be offered to the candidates from the waiting list according to their merit. All applicants must provide phone numbers and e-mail for faster communication.
