- An earnest money of Rs. 30,000/- (Rupees Thirty thousand) must be deposited in the form of demand draft order payable to "AIIMS Kalyani, State Bank of India (AIIMS Branch)
- If tenderer does not accept the offer, after issue of letter of award by Institute within 15 days, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited.
- 5. The rates quoted by each firm for contract in tenders be given both in words and figures failing which the same is liable to be rejected. The name and address of the representative who would be attending the opening of the tenders on tenderer's behalf should be indicated in the tenders. Name and address of permanent representative of the tenderer, if any, may also be indicated.
- 6. The Institute is **not bound to accept** the **lowest** or any other **tenders** and also reserve to itself the right of accepting the tenders in whole or in part. You are, however, at liberty to submit Tenders for the whole or any portion or to state in the tenders that the rates quoted shall apply only if the tenders are considered fully. Other conditional Tenders will not be accepted.
- 7. Performance Security @ 5% of the anticipated overall drawl during the contract period, will be obtained at the time of award of rate-contract, from the successful contract awardee(s), in the shape of Demand Draft/Bank Guarantee drawn in favour of "AIIMS Kalyani", which will be refunded after satisfactory completion of contract. In the event of non-deposition of the same, the earnest money will be forfeited. The security shall be refunded to the contractor after satisfactory completion of the contract or adjusted against any damages or loss of property etc. caused by the personnel deputed by the agency. No interest will be paid on the security money deposited with the Institute.
- The GST or any other tax which is as per the rules of the Govt., shall be deducted at source from bills of the successful tenderer, as per rules/instructions made applicable from time to time.
- 9. Decision of the Executive Director of the Institute shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract, will be settled at his/her level by mutual consultation and in case of failure of settlement, the dispute shall be referred to the sole arbitrator to be appointed by the Executive Director of the Institute. The decision of the sole Arbitrator so appointed shall be final and binding on the parties. Arbitration proceedings shall be governed by the Arbitration & Constitution Act, 1996.
